We have developed this policy to ensure our donors that donor information will not be shared with any third party. This privacy policy applies to collection of information, including information collected on our website. By submitting your information to us or any of our staff, you consent to the terms and conditions of the policy and to our processing personal information for the purposes stated below.

Personal Information

"Personal Information" is information that identifies you personally, such as your name, church or organization, address, telephone number, and email address. We collect and store the information that you provide to us. Here are some examples of ways in which we may collect your information.

When you request information via one of the email addresses identified on our website or contact us in person, by phone or email. We may then collect your personal information in order to respond to that inquiry.

We may collect your name, email address and other contact information if you register for an event or participate on a mission trip.

We may collect your name, email address, telephone number and payment information when you make a contribution, either on our website, over the phone or by mail.

The above list provides a sample of personal information that may be collected by HFHC. From time to time, we may collect personal information from you in ways not specifically described above.

Use and Disclosure of Personal Information

HFHC uses your information to understand your needs and provide you with better service. Specifically, we use your information to help you complete a transaction, communicate back to you, and update you on ministry happenings. Payment information is used only for donation or payment processing and is not retained for other purposes. We use the comments you offer to provide you with information requested, and we take seriously each recommendation as to how we might improve communication.

- We will not sell, trade, or share your personal information, collected on the website or through any other business activities with anyone else.
- We will not send you mailings on behalf of other organizations.
- We will only share your personal information if you give us specific permission to do so.
- We will collect payment information, billing address and other information necessary to process a donation or event registration.
- We will use your information to comply with the law or in the good faith belief that such action is
 necessary to conform to the requirements of law, protect and defend our rights or act in urgent

circumstances to protect the personal safety of others.

We will use the personal information to protect against potential fraud. We may verify with third
parties the information collected in the course of processing a gift, event registration or other
donation. If you use a credit or debit card on the website, we may use card authorization and
fraud screening services to verify that your card information and address matches the
information that you supplied to us and that the card being used has not been reported lost or
stolen.

All online donations are processed through Network for Good, which uses industry-leading Secure Sockets Layer (SSL) technology to keep your personal information as secure as possible and protect against the loss, misuse and alteration of the information under our control. All information is stored in a secure database. All in-house donations are processed through FrontStream, which uses secure server software (SSL) and firewalls to protect your information from unauthorized access, disclosure, alteration, or destruction.
