CHILD SPONSORSHIP PROGRAM Provides funding for underprivileged Haitian children to receive a quality education at one of 10 Christian schools established by HFHC in partnership with the local churches of Christ The schools, located in the central and west departments of Haiti, with three of them in the capital city of Port-au-Prince, serve more than 2,500 children In addition to tuition, the child sponsorship program provides for a uniform, a backpack, books, supplies and an end-of-year gift for each child The children also receive an annual medical exam and free access to a medical clinic throughout the year In 2015, 139 children were added to the program Capital improvements were made at four schools, with two receiving new roofs and two receiving school kitchens Three of our schools have lunch programs that provide hot meals and three schools had new wells dug to provide clean water to the school and community We also held a Teacher Training Seminar for our teachers and principals

ORPHAN CARE MINISTRY The orphanage ministry provides ongoing operational funds to sustain two orphanages that provide comprehensive childcare to 84 orphaned children, ages 4 to 18 The Cazeau Orphanage, established in 1998 in the capital city of Port-au-Prince, is home to 72 children The Thomazeau Orphanage, established 30 miles outside of Port-au-Prince in 2012, is home to 12 orphans These are true homes for the children-not only providing the necessities of food, clothing, housing, and medical care, but also providing a loving family In 2015, a food storage facility was built at the orphanage at Cazeau to store food and other donations Additional turkeys and chickens were purchased to continue training the children how to raise animals and provide protein for the family A reverse osmosis system was installed at both orphanages to ensure clean filtered water Improvements to dormitories included new shutters on windows, painting, replacement of the sewer system, and paving the drive leading to the orphanage

MISSION TRIP MINISTRY In 2015, we conducted two major mission trips to Haiti-our Child Care Clinic Mission Trip and our Youth Leadership Camp Mission Trip-as well as 13 small group mission trips Over 80 volunteers, including doctors, nurses, dentists, and other healthcare workers gave of their time and talents to serve over 1,700 children at our Annual Child Care Clinic In August, 22 volunteers traveled to Haiti to help conduct the Youth Leadership Camp for 180 sponsored teens ages 13-17 This is primarily a spiritual event focusing on Bible classes and devotionals, but also included time for fun activities namely soccer and a talent show The HFHC Hope Center Mission House provided the facility for 13 summer teams 164 individuals from various college campuses and churches to stay and complete projects at our schools, orphanages, and Hope Center Throughout the year, they built a 3rd grade classroom, painted school and orphanage facilities, engaged the children with Vacation Bible School programs, distributed food and supplies, and repaired water and drinking systems
