 Child Sponsorship Ministry provides funding for underprivileged Haitian children to receive a quality education at one of 10 Christian schools established by HFHC in partnership with the local churches of Christ The schools, located in the central and west departments of Haiti, with three of them in the capital city of Port-au-Prince, serve more than 2,500 children In addition to tuition, the child sponsorship program provides for a uniform, a backpack, schools books, school supplies, and an end-of-the-year gift for each child The children also receive an annual medical exam and paid access to medical clinic throughout the year In 2016, 198 children were added to the program Capital improvements were made at our schools which included additional classrooms built onto two schools, walls and a security gate at Hinche, new school bathroom latrines at two schools, and a computer lab at our secondary school All schools received new school benches and desks Three of our schools have lunch programs that provide hot meals One new vehicle was purchased to facilitate school

 Orphan Care Ministry provides ongoing operational funds to sustain two orphanages that provide comprehensive childcare to 84 orphaned children, ages 4 to 18 The Cazeau Orphanage, established in 1998 in the capital city of Port-au-Prince, is home 72 children The Thomazeau Orphanage, established 30 miles outside of Port-au-Prince in 2012, is home to 12 orphans These are true homes for the children, not only providing the necessities of food, clothing, housing, and medical care, but also providing a loving family In 2016, a new kitchen and dining hall was built at the Thomazeau orphanage A new 300 gallon PVC water tank was purchased for the Cazeau Orphanage 12 of our older children, ages 15-17, are taking a sewing class to learn the basics of sewing We took the children on a field trip to the beach and bought new bicycles for them to ride

 Mission Trip Ministry HFHC led two major mission trips to Haiti- Child Care Clinic Mission Trip and Youth Leadership Camp Mission Trip, as well as hosted 11 small group mission teams Over 60 volunteers including doctors, nurses, dentists, and other healthcare workers gave of their time and talents to serve over 1,700 children at our Annual Child Care Clinic In July, 21 volunteers traveled to Haiti to help conduct the Youth Leadership Camp for 180 sponsored teens ages 13-17 The HFHC Hope Center Mission House provided the facility for 11 summer teams 140 individuals from various college campuses and churches to stay and complete projects at our schools, orphanages, and Hope Center In 2016, these groups built a 4th grade classroom, painted school and orphanage facilities, engaged the children with Vacation Bible School programs, distributed food and supplies, installed an aquaponics project for fish and vegetables, and spent time encouraging the children and staff
