HFHC's Child Sponsorship Ministry provides funding for underprivileged Haitian children to receive a quality education at one of 10 Christian schools established by HFHC in partnership with the local churches of Christ. The schools, located in the central and west departments of Haiti, with three of them in the capital city of Port-au-Prince, serve more than 2,500 children. In addition to tuition, the child sponsorship program provides for a uniform, a backpack, schools books, school supplies, and an end-of-the-year gift. In 2017, each child received a Christmas Joy Box in December. The children also receive an annual medical exam and paid access to a medical clinic throughout the year. 300 children were added to the program in 2017.

4b (Code:) (Expenses \$ 294,240 including grants of \$ 255,896) (Revenue \$)

HFHC's Orphan Care Ministry provides ongoing operational funds to sustain two orphanages that provide comprehensive childcare to 84 orphaned children, ages 4 to 18. The Cazeau Orphanage, established in 1998 in the capital city of Port-au-Prince, is home 72 children. The Thomazeau Orphanage, established 30 miles outside of Port-au-Prince in 2012, is home to 12 orphans. These are true homes for the children - not only providing the necessities of food, clothing, housing, and medical care, but also providing a loving family. In 2017, a new dormitory was built at the orphanage at Thomazeau to provide for the growing needs of the children. At the Cazeau Orphanage, our teenagers are taking classes on sewing, mechanics, and learning to make souvenir bracelets. In addition, 7 of our older teens are going through Entrepreneurship Training and learning how to develop a business plan, set up bank accounts, and practice by running a micro-business.

4c (Code:) (Expenses \$ 199,528 including grants of \$ 179,504) (Revenue \$)

The Thomazeau Mission House provided the facility for 12 summer teams (155 individuals) from various college campuses and churches to stay and complete projects at our schools, orphanages, and the Hope Center. These groups painted school and orphanage facilities, engaged the children with Vacation Bible School programs, distributed food and supplies, worked on an aquaponics project for fish and vegetables, and spent time encouraging the children and staff. In 2017, a water cistern and water tower were built to prepare for our expanded facilities and to serve more children. In addition, local Haitian workers were employed to complete a large security wall and guard tower for our entire Hope Center campus that includes our mission house, orphanage and school. This was our most significant project of the year.

This covers expenses in the U.S. to administer and run all programs in Haiti. Systems are in place to keep communication between our U.S. and Haiti staff constant and stable.

Supplies are purchased and sent to Haiti to for programs including school supplies, teaching materials for the Youth Camp, annual Child Care Clinic, and for the children when they write letters to their sponsors.

SCHOOL LUNCH PROGRAM

Four schools served lunch during the school day. Two city schools in Port-au-Prince (Cazeau and Cite Soleil) served hot nutritious meals five days a week to 533 children. The Thomazeau Christian school serves lunch five days a week to 278 children. This year, a kitchen was built at the Dubuisson School which enabled them to start a school lunch program to serve 205 students in grades K-9th. This program makes a significant impact in the classroom. A child's ability to focus and learn is increased and they attend school more regularly.

SCHOOL DEVELOPMENT PROGRAM

In 2017, many capital improvements were completed at our schools including eight additional classrooms built at four schools, security walls built at two schools, a computer lab and library at our secondary school in Port-au-Prince, and kitchens built at two schools. All schools received new school benches and desks.

JOY BOX/GIFT MIISTRY

In December, Hope for Haiti's Children delivered 2,658 Christmas Joy Boxes to sponsored students and other local children in need. The shoebox-size packages contained a variety of small items for the children to enjoy, as well as a huge bundle of Christmas cheer to remind them they are not forgotten during the holiday season. Twenty-four churches helped with this project.

MISSION TRIP MINISTRY

In 2017, HFHC's Mission Trip Ministry led three major mission trips to Haiti—our Child Care Clinic Mission Trip, Youth Leadership Camp Mission Trip, and Christmas Joy Box Trip. In January, over 60 volunteers including doctors, nurses, dentists, and other healthcare workers gave of their time and talents to serve over 1,550 children at our Annual Child Care Clinic. In July, 19 volunteers traveled to Haiti to help conduct the Youth Leadership Camp for 155 sponsored teens ages 13-16. In addition, we hosted 12 small group mission teams at the Thomazeau Hope Center to help with service projects at the school and community.

HAITI OPERATIONS

Our Haitian staff oversees operations in our ten schools and two orphanages. Haiti Operations covers all in-country expenses related to running each of our programs. It includes their wages, in-country communication, office expenses and transportation costs.

CRISIS RELIEF

The relief efforts from Hurricane Matthew's destruction in October 2016 continued through 2017. The church and school in Chambellan was rebuilt and many homes in the flooded area of Cite Soliel in Port-au-Prince were repaired or rebuilt.

LEADERSHIP CAMP

With a desire to reach more of our sponsored teenagers that are sponsored in our program, two camps were conducted. In June, we conducted a "mini-camp" at our Thomazeau Hope Center to serve 44 students who are 13 years old. Our Annual Leadership Camp was held in July at the Global Outreach rented facility in Titanyen, Haiti. There were 169 teenagers ages 14-16 who attended. These camps are a time of escape from harsh living circumstances and a place where they enjoy time with other teens, play sports, watch movies, and participate in Bible study and discussion groups.
