THOMAZEAU HOPE CENTER IN 2020, LOCAL HAITIAN WORKERS WERE EMPLOYED TO BUILD FOUR CABINS FOR CAMPERS TO USE AS WELL AS A BOYS' BATHROOM FACILITY. PLANS ARE BEING MADE TO CONSTRUCT A FULL HEALTH AND WELLNESS CLINIC. JOY BOX/GIFT MINISTRY IN DECEMBER, HOPE FOR HAITI'S CHILDREN DELIVERED 3,094 CHRISTMAS JOY BOXES TO SPONSORED STUDENTS AND OTHER LOCAL CHILDREN IN NEED. THE SHOEBOX-SIZE PACKAGES CONTAINED VARIOUS SMALL ITEMS FOR THE CHILDREN TO ENJOY, AS WELL AS A HUGE BUNDLE OF CHRISTMAS CHEER TO REMIND THEM THEY ARE NOT FORGOTTEN DURING THE HOLIDAY SEASON. THIRTY U.S. CHURCHES AND GROUPS HELPED WITH THIS PROJECT. IN ADDITION, AT THE END OF THE SCHOOL YEAR, EACH CHILD IS GIVEN 5 BEFORE THEY LEAVE SCHOOL FOR SUMMER VACATION AS A GIFT FROM THEIR SPONSOR. SCHOOL DEVELOPMENT PROGRAM IN 2020, THE CAZEAU CHRISTIAN SCHOOL HAD A MAJOR EXPANSION PROJECT AND TRIPLED IN SIZE - NOW HOUSING A FIRST-FLOOR AUDITORIUM, INDIVIDUAL CLASSROOMS ON THE 2ND FLOOR FOR EACH GRADE, A KITCHEN FACILITY, SCHOOL OFFICE, BATHROOMS, AND A ROOFTOP AREA FOR CALISTHENICS. THE SCHOOLS AT BRAJIROIS, CITE SOLEIL, AND THOMAZEAU BUILT ADDITIONAL CLASSROOMS FOR JUNIOR HIGH CLASSES TO ACCOMMODATE THE GROWTH AT THOSE SCHOOLS, AND THE SCHOOL AT ROBERT REPLACED THE ROOF. AT THE DELMAS CHRISTIAN SCHOOL, PROPERTY WAS PURCHASED BESIDE THE SCHOOL TO CONTAIN A WELL, A SAFE PLACE FOR PARKING, AND A SPACE FOR OUTDOOR RECESS FOR THE CHILDREN. ADDITIONALLY, ALL SCHOOLS RECEIVED NEW SCHOOL BENCHES AND DESKS. MISSION TRIPS IN 2020, 59 VOLUNTEERS AND HEALTHCARE WORKERS CONTRIBUTED THEIR TIME AND TALENTS TO SERVE 2,116 CHILDREN AT OUR ANNUAL CHILD CARE CLINIC. SADLY, WE WERE UNABLE TO INVITE OTHER MISSION TEAM VOLUNTEERS TO SERVE DUE TO THE PANDEMIC. THROUGH ZOOM, A U.S. TEAM WAS ABLE TO CONDUCT LEADERSHIP TRAINING TO FIVE YOUNG MEN IN HAITI WHO LATER LED THE LEADERSHIP CAMP FOR 177 TEENS DURING THE SUMMER. CRISIS RELIEF IN MARCH 2020, HAITI'S BORDERS CLOSED AND HAITIANS WERE AGAIN FACED WITH HARDSHIP AS SCHOOLS AND BUSINESSES SHUT DOWN DUE TO COVID-19 AND CONSTANT POLITICAL INSTABILITY. AS A RESULT, A HUNGER CRISIS ERUPTED. HFHC RESPONDED BY DISTRIBUTING 14,000 POUNDS OF RICE AND 6,700 POUNDS OF BEANS TO OVER 2,000 CHILDREN AND COMMUNITY MEMBERS. IN ADDITION, HOMES WERE BUILT FOR FIVE WIDOWS AND FOUR CHILDREN WHO WERE IN DESPERATE NEED. HAITI OPERATIONS OUR HAITIAN STAFF OVERSEES OPERATIONS IN OUR TEN SCHOOLS AND TWO ORPHANAGES. HAITI OPERATIONS COVERS ALL IN-COUNTRY EXPENSES RELATED TO SUSTAINING EACH OF OUR PROGRAMS. IT INCLUDES STAFF WAGES, IN-COUNTRY COMMUNICATION FEES, OFFICE EXPENSES, GOVERNMENT REQUIREMENTS, AND TRANSPORTATION COSTS. IN 2020, FOUR MOTORCYCLES WERE PURCHASED TO HELP SCHOOL ADMINISTRATORS AND STAFF TRANSPORT SUPPLIES TO REMOTE LOCATIONS AND TO CARRY CHILDREN TO THE DOCTOR IF NEEDED. PROGRAM SERVICE US OPS THIS COVERS EXPENSES IN THE U.S. FOR ADMINISTRATION AND EXECUTION OF ALL PROGRAMS IN HAITI. SYSTEMS ARE STRUCTURED IN ORDER TO KEEP COMMUNICATION BETWEEN OUR U.S. AND HAITI STAFF CONSTANT AND STABLE. VARIOUS ITEMS ARE ACCUMULATED AND/OR PURCHASED, ORGANIZED, AND SHIPPED TO HAITI FROM OUR U.S. OFFICES AS WELL. THESE INCLUDE SCHOOL SUPPLIES, HYGIENE ITEMS, TEACHING MATERIALS FOR THE YOUTH CAMP, MEDICAL NECESSITIES FOR OUR ANNUAL CHILD CARE CLINIC, AND PRINTED PAPERS FOR THE STUDENTS TO USE WHEN THEY WRITE LETTERS TO THEIR SPONSORS. LEADERSHIP CAMP IN ORDER TO FACILITATE LEADERSHIP TRAINING AND DEVELOPMENT AMONG SPONSORED STUDENTS AND HELP YOUNG PEOPLE IN HAITI FIND AND FOLLOW JESUS, FOUR SESSIONS OF CAMP HOPE WERE HELD ON THE CAMPUS OF HFHC'S THOMAZEAU FACILITY IN THE SUMMER OF 2020. ONE HUNDRED SEVENTY-SEVEN (177) TEENS ATTENDED THREE-DAY CAMPS AND ENGAGED IN BIBLE STUDY AND DISCUSSION GROUPS, TEAM GAMES AND RELAYS, ARTS AND CRAFTS PROJECTS, AND A CAMP-WIDE TALENT SHOW. WE WERE THRILLED TO SEE 72 CHILDREN ACCEPT CHRIST AND BE BAPTIZED. IN THIS 17TH YEAR OF HFHC SUMMER CAMPS, CAMP HOPE PROVIDED A WARM AND INVITING CHRIST-CENTERED ATMOSPHERE WHERE STUDENTS FROM ALL TEN SCHOOL COMMUNITIES FELT WELCOMED, VALUED, AND DEEPLY LOVED.

ADDITIONALLY, ALL SCHOOLS RECEIVED NEW SCHOOL BENCHES AND DESKS. MISSION TRIPS IN 2020, 59 VOLUNTEERS AND HEALTHCARE WORKERS CONTRIBUTED THEIR TIME AND TALENTS TO SERVE 2,116 CHILDREN AT OUR ANNUAL CHILD CARE CLINIC. SADLY, WE WERE UNABLE TO INVITE OTHER MISSION TEAM VOLUNTEERS TO SERVE DUE TO THE PANDEMIC. THROUGH ZOOM, A U.S. TEAM WAS ABLE TO CONDUCT LEADERSHIP TRAINING TO FIVE YOUNG MEN IN HAITI WHO LATER LED THE LEADERSHIP CAMP FOR 177 TEENS DURING THE SUMMER. CRISIS RELIEF IN MARCH 2020, HAITI'S BORDERS CLOSED AND HAITIANS WERE AGAIN FACED WITH HARDSHIP AS SCHOOLS AND BUSINESSES SHUT DOWN DUE TO COVID-19 AND CONSTANT POLITICAL INSTABILITY. AS A RESULT, A HUNGER CRISIS ERUPTED. HFHC RESPONDED BY DISTRIBUTING 14,000 POUNDS OF RICE AND 6,700 POUNDS OF BEANS TO OVER 2,000 CHILDREN AND COMMUNITY MEMBERS. IN ADDITION, HOMES WERE BUILT FOR FIVE WIDOWS AND FOUR CHILDREN WHO WERE IN DESPERATE NEED. HAITI OPERATIONS OUR HAITIAN STAFF OVERSEES OPERATIONS IN OUR TEN SCHOOLS AND TWO ORPHANAGES. HAITI OPERATIONS COVERS ALL IN-COUNTRY EXPENSES RELATED TO SUSTAINING EACH OF OUR PROGRAMS. IT INCLUDES STAFF WAGES, IN-COUNTRY COMMUNICATION FEES, OFFICE EXPENSES, GOVERNMENT REQUIREMENTS, AND TRANSPORTATION COSTS. IN 2020, FOUR MOTORCYCLES WERE PURCHASED TO HELP SCHOOL ADMINISTRATORS AND STAFF TRANSPORT SUPPLIES TO REMOTE LOCATIONS AND TO CARRY CHILDREN TO THE DOCTOR IF NEEDED. PROGRAM SERVICE US OPS THIS COVERS EXPENSES IN THE U.S. FOR ADMINISTRATION AND EXECUTION OF ALL PROGRAMS IN HAITI. SYSTEMS ARE STRUCTURED IN ORDER TO KEEP COMMUNICATION BETWEEN OUR U.S. AND HAITI STAFF</p>
