OUR CHILD SPONSORSHIP MINISTRY IS CHANGING LIVES BY GIVING UNDERPRIVILEGED CHILDREN IN HAITI ACCESS TO QUALITY, CHRIST-CENTERED EDUCATION. THROUGH GENEROUS SPONSORS, 2,396 CHILDREN ARE NOW SPONSORED TO ATTEND ONE OF OUR 10 CHRISTIAN SCHOOLS-WHICH ENROLL MORE THAN 4,000 STUDENTS IN PARTNERSHIP WITH LOCAL CHURCHES OF CHRIST. SPONSORSHIP PROVIDES MORE THAN JUST TUITION-IT COVERS SCHOOL UNIFORMS, BACKPACKS, SUPPLIES, A SPECIAL END-OF-YEAR GIFT, AND ACCESS TO HEALTH CARE. IN 2024, WE WELCOMED 427 NEW CHILDREN INTO THE SPONSORSHIP PROGRAM.
